- items and also submit evidence of having satisfactorily executed orders for similar supplies works and services for major government departments, statutory bodies and reputed private sector institutions during last 3 years.
- Prospective Suppliers applying for repairing items such as machinery and equipment should have workshop facilities of their own to effect repairs, whenever necessary.
- Applicants shall have proof for financial and other resources to execute orders of high value 05. exceeding Rs. 500,000/= at a time per order. Interested applicants are also requested to submit photocopies of certified audited financial statements for the last three years (Year 2019, 2020 & 2021) in order to prove your financial capability to execute such orders.
